- Applicant must certify that the proposed facility is not located within one (1) mile of an existing tower facility.

 commercially reasonable rates, provided such facilities are structurally and technically able to
 accommodate additional providers.
- If the applicant has not previously provided Sampson County with a copy of the FCC license of the WCF user(s), it must do so with this application.
- Copies of all relevant portions of executed leases for the proposed site demonstrating compliance with the local wireless telecommunication facility rules and regulations.
- Application fees are as follows: \$500 for an installation onto an existing structure or for a new telecommunications tower, \$500 for a Radio Frequency Intermodulation Study (collocation only).
- Complete site development plans; including but not limited to tower design plans, site survey, site plan, adjacent owners, legal description of the proposed site and estimated construction time schedules.
