# Who Are We?

Sampson Soil & Water Conservation District (SWCD) is comprised of a board of supervisors, of which three are elected in the general election and two are appointed by the NC Soil & Water Conservation Commission. The District supervisors are charged with the protection of the county's soil, water and related resources and establishing conservation programs in the county. The staff assigned to carry out the District's mission include one soil conservationist, two district technicians and an administrative assistant. A District Conservationist is provided by USDA-NRCS. The Sampson SWCD mission is also supported by several state and federal cost share programs that assist landowners in Sampson County with the cost of installation of Best Management Practices (BMPs). For the

2013 program year, these programs brought in over \$600,000 into Sampson County in the form of direct payments and incentives to farmers and landowners to install on-farm conservation practices to solve natural resource concerns.

## Summary of 2013 **Agriculture Cost Share Program &** Agricultural Water Resources Assistance Program

 ${
m The~NC~Agricultural~Cost~Share~Program~(NCACSP)}$  is a state funded program that provides technical and financial assistance to address nonpoint source pollution. For the 2013 program year, the Sampson County Soil and Water Conservation District was allocated \$62,290 by the NC Soil and Water Conservation Commission. This money was

used to cost share general conservation practices such as cropland conversion, crop residue management, field borders, grassed waterways, long term no-till, erosion control and fencing. The District received an allocation of \$63,000 for the Agricultural Water Resources Assistance Program (AgWRAP). Funds will be used to increase water availability and storage thru the construc-

tion of 4 agricultural ponds. A total of 23 contracts were obligated through the NCACSP and AgWRAP.

#### **Market Based Conservation Initiative**

Sampson SWCD partnered with the NC Foundation for Soil and Water to promote the Market Based Conservation Initiative (MBCI) Pilot Program in Sampson County.



The MBCI Program's purpose is to test alternative methods to protect rural land from development under an existing military flight path. The District and NRCS staff assisted in the submission of 130 applications from interested landowners in the county and at least one more bid round will occur.

### **Summary of Federal Programs** FY 2012-2013

The funding for the Environmental Quality Incentives Program (EQIP) program year 2013 was approximately \$550,000 and was used to cost share practices such as an Animal Mortality Facilities, Waste

Storage Facilities (Litter Sheds), Conservation Crop Rotation, Tree/Shrub Site Preparation, Tree/Shrub Establishment, Prescribed Burning, Firebreaks, Forest Stand Improvement, Nutrient Management, Micro-irrigation, Irrigation Water Management Conservation Activity Plan, Farmstead Energy Improvement and Agricultural Energy Management Conservation Activity Plan. A total of 23 EQIP contracts were obligated. NRCS and the Sampson

District staff continue to assist the Farm Service Agency (FSA) by writing conservation plans for the Conservation Reserve Program (CRP). Payments for all active federal contracts in this fiscal year totaled over \$1 million.

Staff provided participants with resources and information on federal and state cost share programs. There were approximately 20 in attendance.

In October 2012, Tenna Autry, District Administrative Assistant, Melanie Harris, District Director, Gavin Thompson, former District Soil Conservationist and Henry Faison, District Soil Conservation Technician, volunteered to work at the Soil and Water Conservation Booth.



#### **NCASWCD Annual Meeting**

The Annual meeting for the NC Association of Soil and Water Conservation Districts to develop policy and elect leadership was attended by Renée Leech and the District Board of Supervisors in January 2013.

#### **NCASWCD Area 7 Spring Meeting**

The Sampson SWCD hosted the Area 7 Spring meeting in February 2013. Craig Thornton, SWCD Board Chairman is the Area 7 Chair. Tenna Autry, coordinates the meetings, poster and speech contests, area activities and is also the Area 7 Planning Coordinator for 2013.
